

PARENTAL ACKNOWLEDGEMENT, AUTHORIZATION, RELEASE AND INDEMNIFICATION AGREEMENT

IN CONSIDERATION of being permitted to enroll my child or ward, _____
(the "Student") in the Power Up class (the "Class"), each of the undersigned, for him/herself, representative, assigns,
heirs, and next of kin:

1. HEREBY ACKNOWLEDGES AND CERTIFIES that he/she will participate in the Parent Orientation meeting, to fully understand what the Power Up class will present to the Student, including, among other things, demonstrations, meditative, and other mental techniques, games, skills, role playing and many other participatory activities, and understands that he/she, as parent or legal guardian, is welcome to enter the class at any time to observe and participate in the class;
2. HEREBY AUTHORIZES the Love and Peas Foundation, its owners, directors, officers, agents, employees, and independent contractors (the "Releasees") to obtain medication that the Student may require and to grant permission for necessary medical treatment and related procedures that the Student may require, and certifies that the allergies of the Student and any and all medical problems that might be important or at all relevant to an individual rendering medical treatment to, or performing related procedures for the Student are set forth below;
3. HEREBY PROMISES NOT TO SUE, RELEASES, AND DISCHARGES THE RELEASEES from any and all liability to him/her, his/her personal representative, assigns, heirs, and next of kin and the to Student for all loss or damages, and any claim or demands therefore, on account of physical injury to, or behavior modification or death of, the Student, whether caused by negligence of RELEASEES or attending medical personnel, or otherwise resulting from or arising out of participation in the Class or otherwise;
4. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES and each of them for any loss, liability, damage, or cost they may incur due to the participation of the Student in the Class or otherwise; and
5. HEREBY WARRANTS that the following statements are true and correct and understands that the RELEASEES have relied upon them in permitting the Student to enroll in the Class:
 - (a) None of the RELEASEES has made any oral representations, statements, or inducements to him/her other than those set forth in this written Agreement.
 - (b) He/she is 18 or more years of age.
 - (c) He/she assumes full responsibility for and all risk of bodily injury to, and behavior modification or death of the student, whether due to the negligence of the RELEASEES or otherwise;
 - (d) He/she is the parent or legal guardian of the Student, and
 - (e) HE/SHE HAS READ AND VOLUNTARILY SIGNS THIS PARENTAL ACKNOWLEDGMENT, AUTHORIZATION, RELEASE AND INDEMNIFICATION AGREEMENT
